Summary of opinion¹ (post authorisation)

Zonegran

zonisamide

On 24 May 2012, the Committee for Medicinal Products for Human Use (CHMP) adopted a positive opinion recommending a variation to the terms of the marketing authorisation for the medicinal product Zonegran. The marketing authorisation holder for this medicinal product is Eisai Ltd. They may request a re examination of the CHMP opinion, provided that they notify the European Medicines Agency in writing of their intention within 15 days of receipt of the opinion.

The CHMP adopted a new indication as follows:

- monotherapy in the treatment of partial seizures, with or without secondary generalisation, in adults with newly diagnosed epilepsy (see 5.1);

Detailed conditions for the use of this product will be described in the updated summary of product characteristics (SmPC), which will be published in the revised European public assessment report (EPAR), and will be available in all official European Union languages after the variation to the marketing authorisation has been granted by the European Commission.

For information, the full indications for Zonegran will be as follows²:

Zonegran is indicated as:

- **monotherapy in the treatment of partial seizures, with or without secondary generalisation, in adults with newly diagnosed epilepsy(see 5.1);**
- adjunctive therapy in the treatment of partial seizures, with or without secondary generalisation in adult patients.
