COMMITTEE ON HERBAL MEDICINAL PRODUCTS (HMPC)

Meeting report, 7 September 2006

The Committee on Herbal Medicinal Products met for the 13th time at the EMEA offices on 7 September 2006.

Report from the Working Party on Community Monographs and Community List (MLWP)

The 4th meeting of the permanent HMPC Working Party on Community Monographs and Community List (MLWP) was held on 5-6 September 2006.

The Rapporteur presented to the MLWP a consolidated version of the

 'Guideline on the assessment of clinical safety and efficacy in the preparation of Community herbal monographs for well-established and of Community herbal monographs /entries to the Community lists for traditional herbal medicinal products / substances / preparations' (EMEA/HMPC/104613/2005)

The consolidated version incorporates comments received during the consultation period. The HMPC subsequently adopted the final guideline together with an overview of comments received. Both documents can be found on the EMEA website at: http://www.emea.europa.eu/htms/human/hmpc/hmpcguide.htm

After coordination with the CHMP the following HMPC guideline, adopted in July 2006, is now available on the EMEA website together with an overview of comments received during the consultation period:

The MLWP made significant progress in the area of Community herbal monographs. The following final documents were adopted by the HMPC further to recommendations from the MLWP:

- 'Community herbal monograph on *Cassia senna* L., fructus / *Cassia angustifolia* VAHL, fructus (EMEA/HMPC/51871/2005)
- 'Community herbal monograph on *Cassia senna* L., folium / *Cassia angustifolia* VAHL, folium (EMEA/HMPC/51869/2005)

- 'Community herbal monograph on *Aloe barbadensis* Miller / Community herbal monograph on *Aloe* (various species, mainly *Aloe ferox* Miller and its hybrids) (EMEA/HMPC/76310/2006)
- 'Community herbal monograph on *Rhamnus frangula* L., cortex (EMEA/HMPC/76307/2006)

In addition, the MLWP had a discussion on the responses to general comments received during consultation periods on draft Community herbal monographs and/or entries to the Community list. The following document was adopted by the HMPC, further to recommendations from the MLWP:

- 'Response document to general comments received on draft Community herbal monographs / entries to the Community list (EMEA/HMPC/160937/2006)

It is expected that the document will be continuously updated, reflecting future comments that address general aspects of Community herbal monographs.

The final Community herbal monographs, as well as their respective assessment report and overview of comments received during the consultation period, will be prepared for publication and, when available, published together on the EMEA

On recommendation of the MLWP, the HMPC also adopted the following draft Community herbal monographs for release for public consultation:

- 'Community herbal monograph on *Pimpinella anisum* L., fructus' (EMEA/HMPC/137423/2006)
- 'Community herbal monograph on *Pimpinella anisum* L., aetheroleum' (EMEA/HMPC/263273/2006)
