	 Working group to address issues with EU multi-languages of Young patient advisory groups (YPAG) 	
	A plan for education and training of young people advisory groups working in specific areas will be pursued in the next year.	
	The Group is supportive of the creation of an EU young person advisory group network for harmonisation. The aim will be to establish a platform to promote common practices in the different EU countries. The working group identified the need to develop a database of YPAGs. The details of setting up such network and database should be discussed with and implemented together with EMA patient and consumer working party to avoid duplication and ensure synergies.

	The Working Group worked toward a model showing how industry can engage with Enpr-EMA/networks to be available on the EnprEMA website. Industry perspective &	The presentation focused on feasibility of conducting paediatric clinical trials and on the role that networks can have in assessing such aspect.
