BACKGROUND INFORMATION ON THE PROCEDURE

1. Submission of the dossier

The company Novo Nordisk A/S submitted on 2 July 2001 an application for Marketing Authorisation to the European Agency for the Evaluation of Medicinal Products (EMEA) for Ultratard, in accordance with the centralised procedure falling within the scope of Part A of the Annex to Council Regulation No (EEC) 2309/93 of 22 July 1993.

2. Steps taken for the assessment of the product

- The procedure started on 17 July 2001
- The Rapporteur's first Assessment Report was circulated to all CPMP Members on 25 September 2001. The Co-Rapporteur's first Assessment Report was circulated to all CPMP Members on 25 September 2001
- During the meeting on 13-15 November 2001 the CPMP agreed on the consolidated List of Questions to be sent to the company. The final consolidated List of Questions was sent to the company on 16 November 2001.
- The company submitted the responses to the consolidated List of Questions on 18 January 2002
- The Rapporteur and the Co-Rapporteur circulated the Joint Assessment Report on the company's responses to the List of Questions to all CPMP members on 22 February 2002
- During the meeting on 19-21 March 2002 the CPMP agreed on a list of outstanding issues.
- The company submitted additional information on 25 March 2002.
- The Rapporteur and the Co-Rapporteur circulated the response Assessment Report on the company's additional information on 15 April 2002.
- During the meeting on 23-25 April 2002 the CPMP, in the light of the overall data submitted and the scientific discussion within the Committee, issued a positive opinion for granting a Marketing Authorisation to Ultratard on 25 April 2002.
- The CPMP opinions were forwarded, in all official languages of the European Union, to the European Commission, which adopted the corresponding Decisions on 7 October 2002.
