## 4. Clinical particulars

### 4.1. Therapeutic indications

Well-established use	Traditional use
	<p>Traditional herbal medicinal product for relief of mild symptoms of mental stress and to aid sleep.</p> <p>The product is a traditional herbal medicinal product for use in the specified indication exclusively based upon long-standing use.</p>

### 4.2. Posology and method of administration

Well-established use	Traditional use
	<p><b>Posology</b></p> <p><i>Adolescents, adults and elderly</i></p> <p><b>Oral Use</b></p> <p>single dose: 15 mg</p> <p>For relief of mild symptoms of mental stress up to 3 times daily.</p> <p>To aid sleep, two single doses half to one hour before bedtime.</p> <p><b>Use as bath additive</b></p> <p>single dose: 240-400 mg for a full bath, up 3-4 times per week</p> <p>The use in children under 12 years of age is not recommended (see section 4.4 'Special warnings and precautions for use').</p> <p><b>Duration of use</b></p> <p>If symptoms persist during the use of the medicinal product, a doctor or a qualified health care practitioner should be consulted.</p> <p><b>Method of administration</b></p> <p>Oral use.</p> <p>Use as bath additive. Temperature: 34-37°C duration of bath 10-20 minutes.</p>

### 4.3. Contraindications

Well-established use	Traditional use
	<p>Hypersensitivity to the active substance</p> <p><b>Use as bath additive</b></p> <p>Full baths are contraindicated in cases of open wounds, large skin injuries, acute skin diseases, high fever, severe infections, severe circulatory disturbances and cardiac insufficiency.</p>

### 4.4. Special warnings and precautions for use

	<p>The use in children under 12 years of age has not been established due to lack of adequate data.</p> <p>If the symptoms worsen during the use of the medicinal product, a doctor or a qualified health care practitioner should be consulted.</p>

### 4.5. Interactions with other medicinal products and other forms of interaction

### 4.6. Fertility, pregnancy and lactation

Well-established use	Traditional use
	<p>Safety during pregnancy and lactation has not been established. In the absence of sufficient data, use during pregnancy and lactation is not recommended.</p> <p>No fertility data available.</p>

### 4.7. Effects on ability to drive and use machines

Well-established use	Traditional use
	<p>May impair ability to drive and use machines. Affected patients should not drive or operate machinery.</p>

#### 4.8. Undesirable effects

Well-established use	Traditional use
	<p><b>Oral use</b></p> <p>Gastrointestinal symptoms (e.g. nausea, abdominal cramps) may occur after ingestion of valerian root preparations. The frequency is not known.</p> <p>If other adverse reactions not mentioned above occur, a doctor or a qualified health care practitioner should be consulted.</p> <p><b>Use as bath additive</b></p> <p>None known.</p> <p>If adverse reactions occur, a doctor or a qualified health care practitioner should be consulted.</p>

#### 4.9. Overdose

Well-established use	Traditional use
	<p><b>Oral use</b></p> <p>Valerian root at a dose of approximately 20 g caused symptoms, such as fatigue, abdominal cramp, chest tightness, lightheadedness, hand tremor and mydriasis, which disappeared within 24 hours. If symptoms arise, treatment should be supportive.</p> <p><b>Use as bath additive</b></p> <p>No case of overdose has been reported.</p>
