

15 September 2014 EMA/MB/406461/2014 Noted Management Board meeting of 2 October 2014

Outcome of written procedures finalised during the period from 13 May 2014 to 1 September 2014

Issues for consideration

This document is presented in accordance with Article 4 (5) of the Management Board rules of procedure regarding the outcome of the written procedures.

During the period from 13 May 2014 to 1 September 2014, the Board was consulted 6 times via written procedures, out of which 3 consultations concerned new memberships in the CVMP and CHMP, and 3 consultations concerned the adoption of the Mandate of the data gathering Steering Group, the adoption of European Medicines Agency Policy on the publication of Clinical Data for medicinal products for human use and the adoption of 84th Management Board meeting minutes, as follows:

- Consultation no. 05/2014 on the appointment of Hrefna Guðmundsdóttir as CHMP alternate, proposed by Iceland, ended on 3 July 2014. The mandate of the nominee commenced on 4 July 2014.
- Consultation no. 06/2014 on the appointment of Maria Popova-Kiradjieva as CHMP Alternate, proposed by Bulgaria, ended on 29 July 2014. The mandate of the nominee commenced on 30 July 2014.
- Consultation no. 07/2014 on the appointment of Emil Kozhuharov as CVMP member, proposed by Bulgaria, ended on Thursday, 7 August 2014. The mandate of the nominee commenced on 8 August 2014.
- Written procedure for the adoption of the Mandate of the data gathering Steering Group ended on 3 July 2014. The mandate was adopted
- Written procedure for the adoption of European Medicines Agency Policy on the publication of Clinical Data for medicinal products for human use was suspended on 4 July 2014.
- Written procedure for adoption of 84th Management Board meeting minutes ended on 30 July 2014. The minutes were adopted.
