Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EC) No 1901/2006 of the European Parliament and of the Council of 12 December 2006 on medicinal products for paediatric use and amending Regulation (EEC) No. 1768/92, Directive 2001/20/EC, Directive 2001/83/EC and Regulation (EC) No 726/2004¹,

Having regard to Regulation (EC) No 726/2004 of the European Parliament and of the Council of 31 March 2004 laying down Community procedures for the authorisation and supervision of medicinal products for human and veterinary use and establishing a European Medicines Agency²,

Basis for opinion

Pursuant to Article 22 of Regulation (EC) No 1901/2006 as amended, Forest Laboratories UK Limited submitted to the European Medicines Agency on 15 March 2013 an application for modification of the agreed paediatric investigation plan with a deferral and a waiver as set out in the European Medicines Agency's decision P/7/2009 issued on 27 January 2009, the decision P/32/2010 issued on 10 March 2010, the decision P/178/2010 issued on 24 September 2010, and the decision P/153/2011 issued on 4 July 2011.

The application for modification proposed changes to the agreed paediatric investigation plan.

The procedure started on 15 April 2013.

Scope of the modification

Some measures and/or timelines of the Paediatric Investigation Plan have been modified.

Opinion

1. The Paediatric Committee, having assessed the application in accordance with Article 22 of Regulation (EC) No 1901/2006 as amended, recommends as set out in the appended summary report:
 - to agree to changes to the paediatric investigation plan in the scope set out in the Annex I of this opinion.

The Norwegian Paediatric Committee member agrees with the above-mentioned recommendation of the Paediatric Committee.

2. The measures and timelines of the paediatric investigation plan and the subset(s) of the paediatric population and condition(s) covered by the waiver are set out in the Annex I.

The subset(s) of the paediatric population and condition(s) covered by the waiver and the measures and timelines of the agreed Paediatric Investigation Plan

1. Waiver

1.1. Condition: treatment of Pseudomonas aeruginosa pulmonary infection / colonisation in patients with cystic fibrosis

The waiver applies to:

- the paediatric population from birth to less than 6 years;
- for inhalation powder, hard capsule for inhalation use;
- on the grounds that the specific medicinal product is likely to be unsafe because of the difficulties of handling a dry powder inhaler device in this age group and the high amount of powder applied.

2. Paediatric Investigation Plan

2.1. Condition: treatment of Pseudomonas aeruginosa pulmonary infection / colonisation in patients with cystic fibrosis

2.1.1. Indication(s) targeted by the PIP

Treatment of chronic Pseudomonas aeruginosa pulmonary infection / colonisation in patients with cystic fibrosis.

Treatment of early Pseudomonas aeruginosa pulmonary infection / colonisation in patients with cystic fibrosis.

2.1.2. Subset(s) of the paediatric population concerned by the paediatric development

From 6 years to less than 18 years.

2.1.3. Pharmaceutical form(s)

Inhalation powder, hard capsule; 125 mg.

Condition(s) and authorised indication(s):

Condition: Treatment of *Pseudomonas aeruginosa* pulmonary infection/colonisation in patients with cystic fibrosis.

1. Authorised indication(s):

- Colobreathe is indicated for the management of chronic pulmonary infections due to *Pseudomonas aeruginosa* in patients with cystic fibrosis (CF) aged 6 years and older (see section 5.1).
Consideration should be given to official guidance on the appropriate use of antibacterial agents.

Authorised pharmaceutical form(s):

Inhalation powder, hard capsule (inhalation powder).

Hard transparent gelatin capsules containing a fine white powder.

Authorised route(s) of administration:

Inhalation use.
