The European Medicines Agency,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EC) No 1901/2006 of the European Parliament and of the Council of 12 December 2006 on medicinal products for paediatric use and amending Regulation (EEC) No. 1768/92, Directive 2001/20/EC, Directive 2001/83/EC and Regulation (EC) No 726/2004¹,

Having regard to Regulation (EC) No 726/2004 of the European Parliament and of the Council of 31 March 2004 laying down Community procedures for the authorisation and supervision of medicinal products for human and veterinary use and establishing a European Medicines Agency²,

Having regard to the European Medicines Agency's decision P/19/2009 issued on 4 February 2009,

Having regard to the application submitted by Janssen-Cilag International NV on 28 May 2010 under Article 22 of Regulation (EC) No 1901/2006 proposing changes to the agreed paediatric investigation plan with a deferral and a waiver,

Having regard to the opinion of the Paediatric Committee of the European Medicines Agency, issued on 6 August 2010, in accordance with Article 22 of Regulation (EC) No 1901/2006,

Having regard to Article 25 of Regulation (EC) No 1901/2006,

Whereas:

- (1) The Paediatric Committee of the European Medicines Agency has given an opinion on the acceptance of changes to the agreed paediatric investigation plan,
- (2) It is therefore appropriate to adopt a decision on the acceptance of changes to the agreed paediatric investigation plan.

Basis for opinion

Pursuant to Article 22 of Regulation (EC) No 1901/2006 as amended, Janssen-Cilag International NV submitted to the European Medicines Agency on 28 May 2010 an application for modification of the agreed paediatric investigation plan with a deferral and a waiver as set out in the European Medicines Agency's decision P/19/2009 issued on 4 February 2009,

The application for modification proposed changes to the agreed paediatric investigation plan.

The procedure started on 10 June 2010.

Scope of the modification

The applicant proposed modifications to the agreed PIP to clarify and revise some of the agreed measures and timelines.

Opinion

1. The Paediatric Committee, having assessed the application in accordance with Article 22 of Regulation (EC) No 1901/2006 as amended, recommends as set out in the appended summary report:

- to agree to changes to the paediatric investigation plan in the scope set out in the Annex I of this opinion.

The Norwegian Paediatric Committee member agrees with the above-mentioned recommendation of the Paediatric Committee.

2. The measures and timelines of the paediatric investigation plan are set out in the Annex I.

Annex I

The measures and timelines of the agreed Paediatric Investigation Plan and the subset(s) of the paediatric population and condition(s) covered by the waiver

1. Condition(s)

Chronic plaque psoriasis

1.1. Indication(s) covered

Treatment of moderate to severe plaque psoriasis in adults who failed to respond to, or who have a contraindication to, or are intolerant to other systemic therapies including ciclosporin, methotrexate and PUVA.

2. Waiver

2.1. Condition(s)

Chronic plaque psoriasis

The waiver applies to:

- the paediatric population from birth to less than 6 years
- for solution for injection, subcutaneous use;
- on the grounds that the specific medicinal product does not represent a significant therapeutic benefit over existing treatments.

3. Paediatric Investigation Plan

3.1. Condition to be investigated

Chronic plaque psoriasis

3.1.1. Indication(s) targeted by the PIP

Treatment of moderate to severe chronic plaque psoriasis that cannot be adequately controlled with topical therapy and/or phototherapy

3.1.2. Subset(s) of the paediatric population concerned by the paediatric development

From 6 years to less than 18 years

3.1.3. Pharmaceutical form(s)

Solution for injection, subcutaneous use

Study 7 Setting up of a prospective cohort study/registry to assess long-term safety and long-term impact on growth and development.
