Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EC) No 1901/2006 of the European Parliament and of the Council of 12 December 2006 on medicinal products for paediatric use and amending Regulation (EEC) No. 1768/92, Directive 2001/20/EC, Directive 2001/83/EC and Regulation (EC) No 726/2004¹,

Having regard to Regulation (EC) No 726/2004 of the European Parliament and of the Council of 31 March 2004 laying down Community procedures for the authorisation and supervision of medicinal products for human and veterinary use and establishing a European Medicines Agency²,

Having regard to the European Medicines Agency's decision P/131/2010 issued on 28 July 2010, the decision P/337/2010 issued on 17 December 2010, the decision P/53/2011 issued on 4 March 2011 and the decision P/172/2011 issued on 1 July 2011,

Pursuant to Article 22 of Regulation (EC) No 1901/2006 as amended, Inspiration Biopharmaceuticals EU, Ltd. submitted to the European Medicines Agency on 26 August 2011 an application for modification of the agreed paediatric investigation plan with a deferral as set out in the European Medicines Agency's decision P/131/2010 issued on 28 July 2010, the decision P/337/2010 issued on 17 December 2010, the decision P/53/2011 issued on 4 March 2011 and the decision P/172/2011 issued on 1 July 2011.

The application for modification proposed changes to the agreed paediatric investigation plan.

The procedure started on 7 September 2011.
