**POSITIVE OPINION OF THE PAEDIATRIC COMMITTEE ON
A PRODUCT-SPECIFIC WAIVER FOR**

Basis for opinion

Pursuant to Article 13 of Regulation (EC) No 1901/2006 as amended, GlaxoSmithKline R&D Limited submitted for agreement to the EMA on 21 September 2007 an application for a waiver on the grounds set out in Article 11 of Regulation (EC) No 1901/2006 as amended for the above mentioned medicinal product.

The procedure started on 25 October 2007.

Opinion

The Paediatric Committee, having assessed the waiver application in accordance with Article 13 of Regulation (EC) No 1901/2006 as amended, recommends as set out in the appended summary report, to grant a waiver for all subsets of the paediatric population and all above mentioned conditions in accordance with Article 11(1)(b) of Regulation (EC) No 1901/2006 as amended, on the grounds that the disease or condition for which the specific medicinal product is intended occurs only in adult populations.

The Icelandic and the Norwegian Paediatric Committee member(s) agree(s) with the above-mentioned recommendation of the Paediatric Committee.
