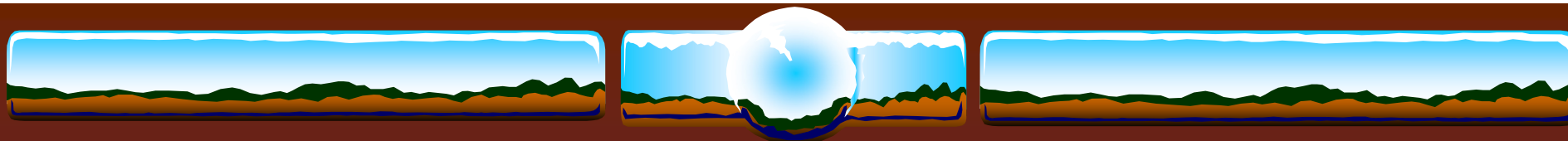

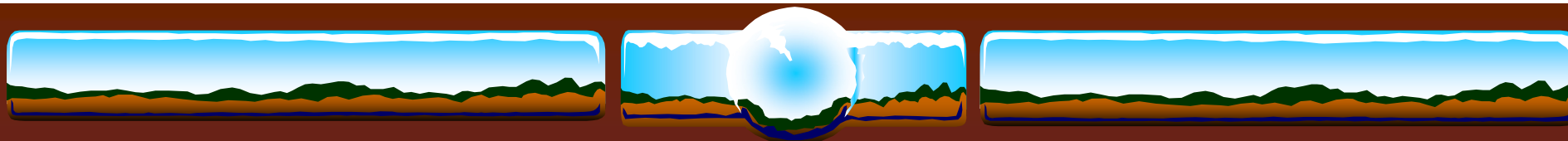

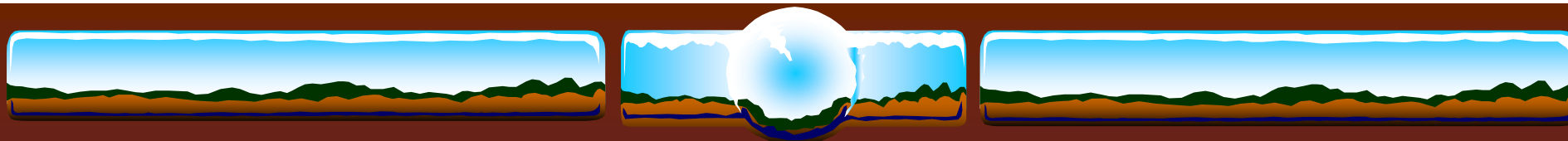


YEARS 2000-2009 (3,425 samples)

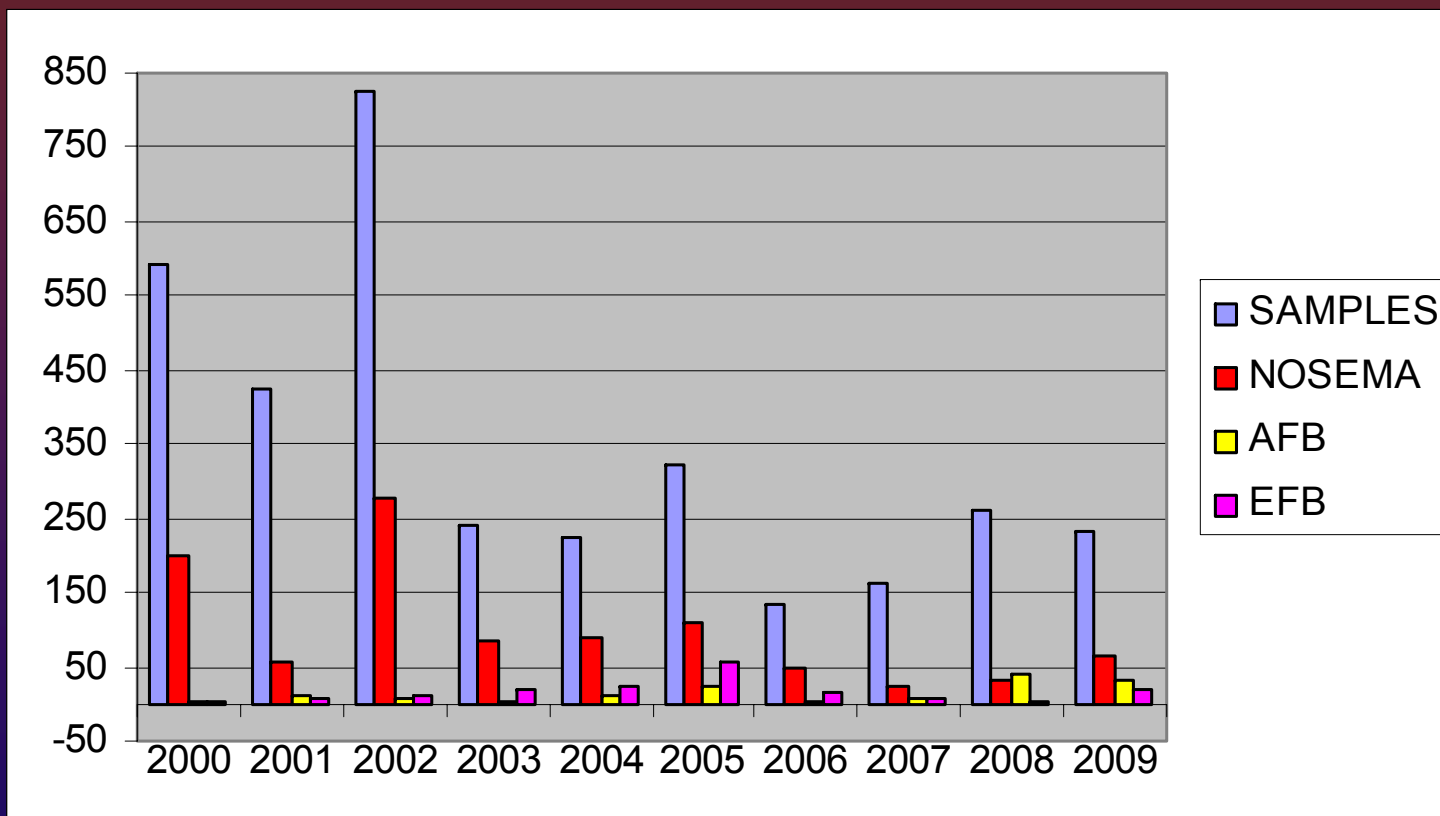

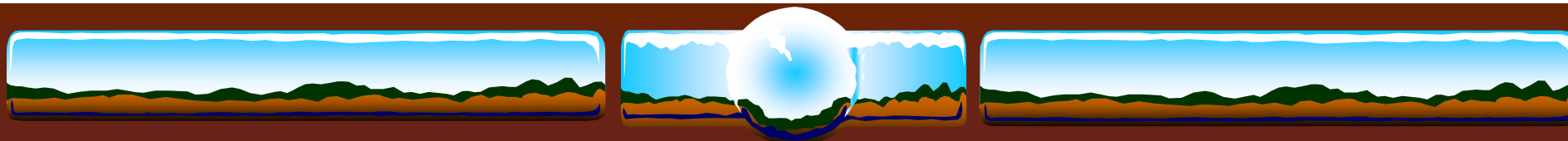
% OF PEST or DISEASE/TOTAL POSITIVE SAMPLES



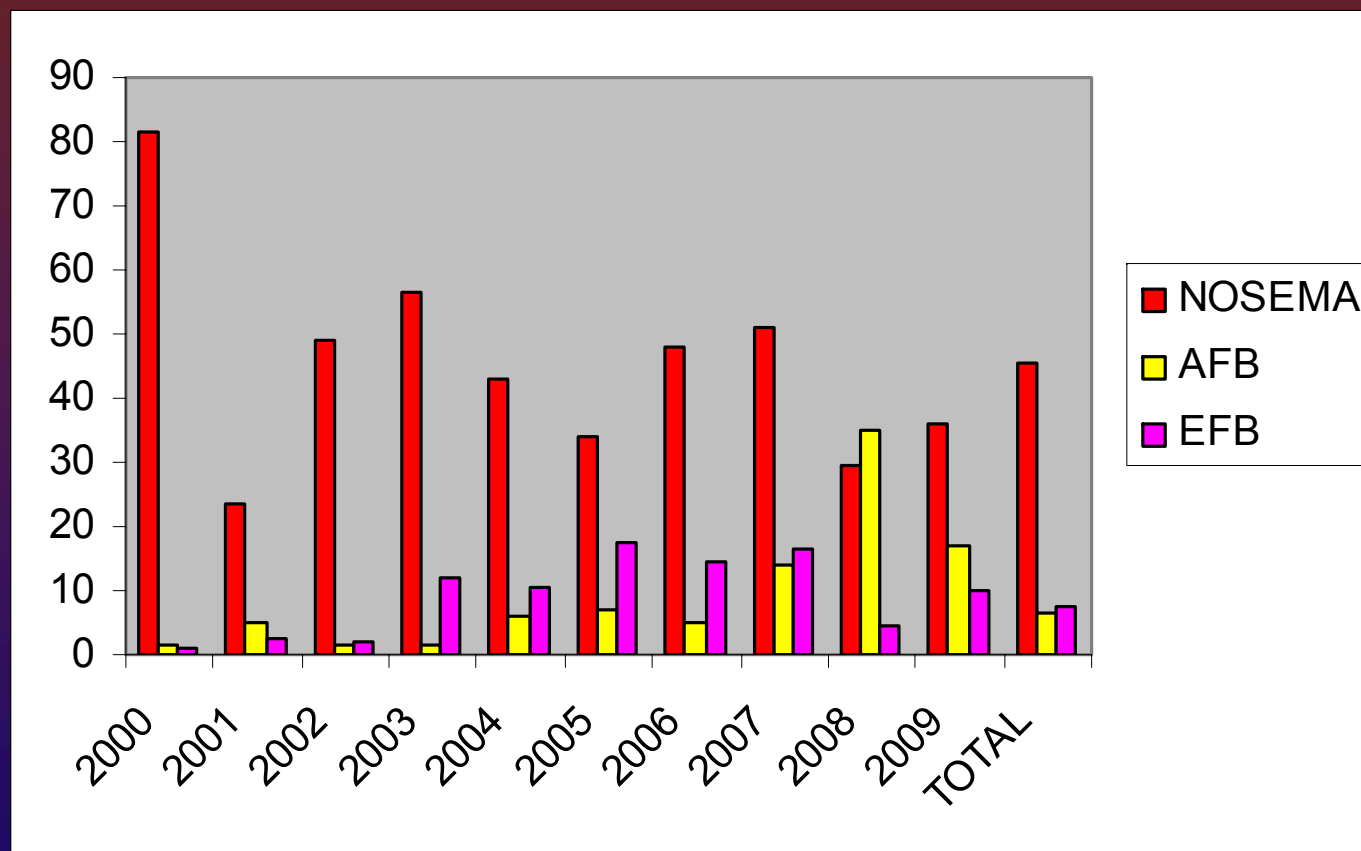


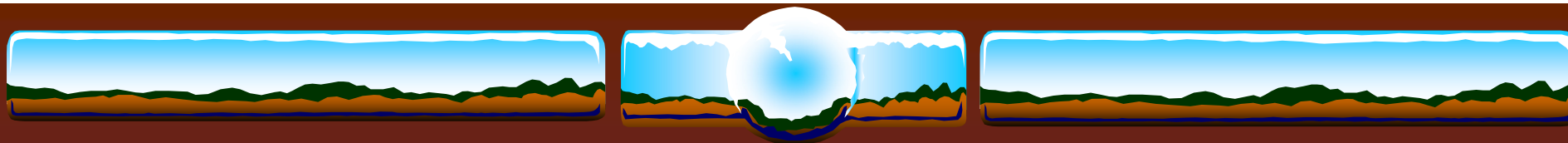
SAMPLES EXAMINED AND FOUND POSITIVE/YEAR FOR NOSEMOSIS, AFB & EFB (Absolute No of samples)



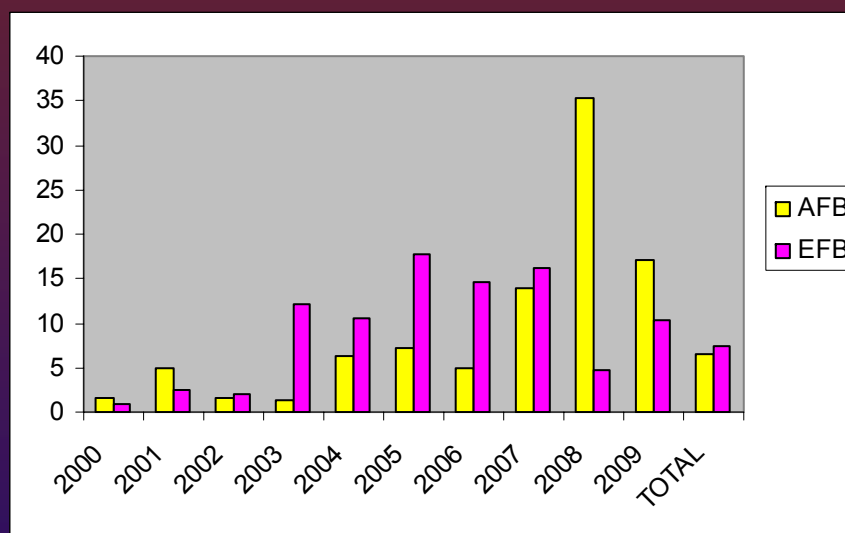
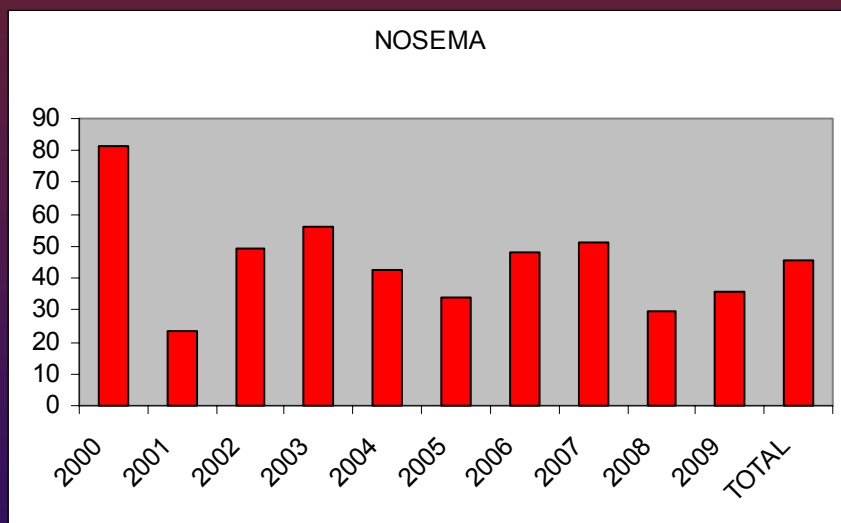


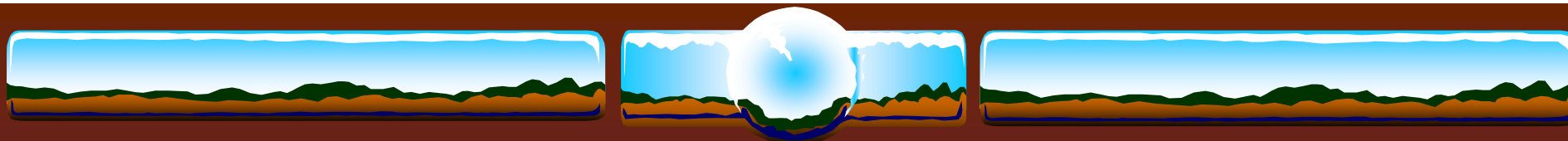
% OF SAMPLES POSITIVE FOR NOSEMOSIS, AFB & EFB /TOTAL POSITIVE SAMPLES/YEAR

TO CONCLUDE:

- HIGH NUMBER OF POSITIVE SAMPLES FOR NOSEMOSIS THROUGHOUT THE 10-YEAR PERIOD
 - ~ ~ No VMP available
- MODERATE INFESTATION OF AFB & EFB
 - ~ ~ No VMP available
- NEW POSSIBLE THREATS – ISOLATION OF NEW SPECIES OF NOSEMA (*N. CERANAE*) – UNKNOWN IMPACT
- NEED FOR ANNUAL SURVEILLANCE PROGRAMMES & BETTER DATA



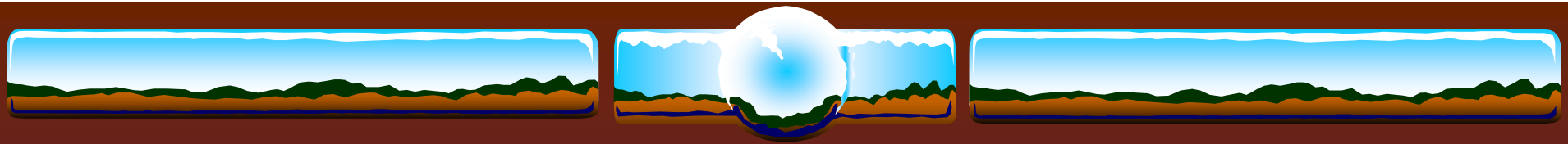

under the direct supervision of the State Veterinary Services.

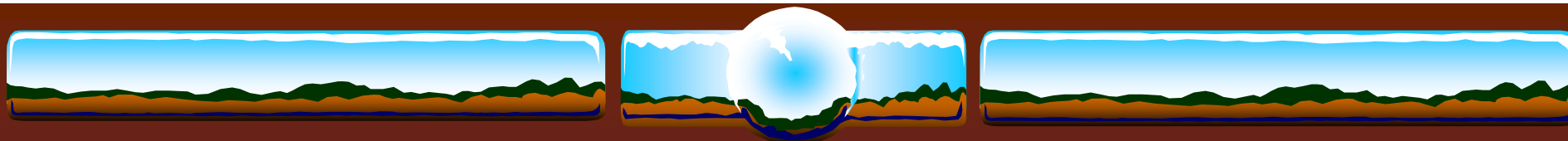
PROCEDURE

1. REQUEST FOR EXAMINATION BY THE BEEKEEPER
2. SAMPLE EXAMINED AT A VETERINARY LAB
3. VETERINARY PRESCRIPTION FOR THE VMP IN
QUANTITY NECESSARY FOR ONE TREATMENT
ONLY
4. PRESCRIPTION POSSIBLE ONLY DURING A LIMITED
TIME PERIOD OF THE YEAR, FAR FROM THE
PERIOD OF HONEY COLLECTION





5. BEEKEEPER'S REQUEST AT THE NATIONAL ORGAN. FOR MEDICINES FOR IMPORT OF A SPECIFIC QUANTITY OF THE VMP
6. THE NAT. ORG. FOR MEDICINES INFORMS THE COMPANY IMPORTING FOR THE TOTAL QUANTITY NEEDED
7. MEDICINAL PRODUCT DISPATCHED TO THE BEEKEEPER BY THE IMPORTING COMPANY
8. BEEKEEPER INFORMS THE STATE VETS ON START AND END OF TREATMENT
9. IMPORTING COMPANY UNDER THE SUPERVISION OF THE NATIONAL ORGANISATION FOR MEDICINES

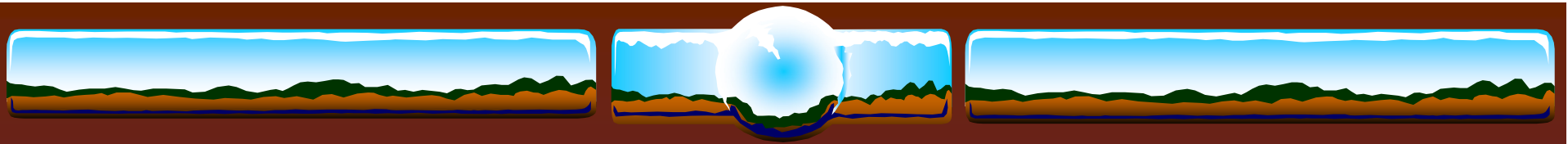

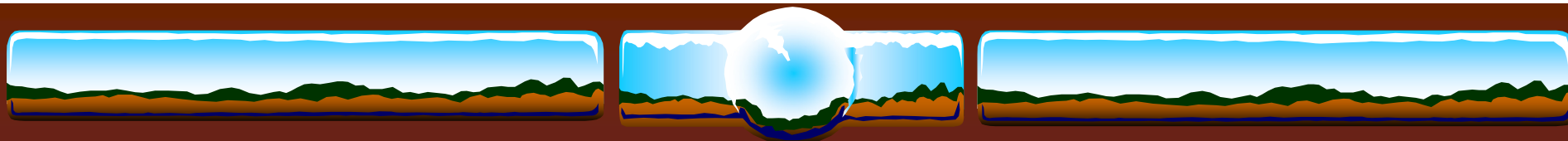

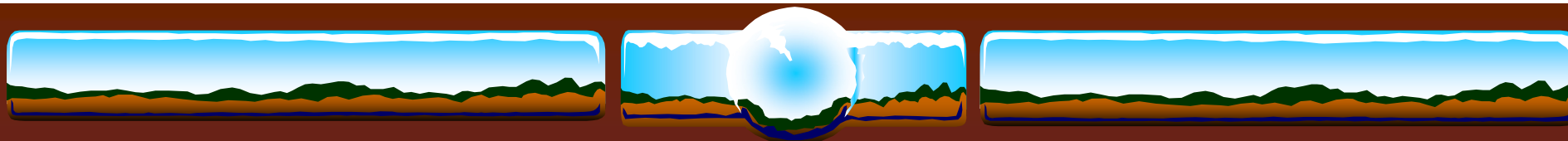
- Until end of 2000: Use of TERRAMYCIN (OTC)

- The “CASCADE” procedure is not helpful
 - since there is ‘zero tolerance’ for antibiotics in

HOWEVER,

Reg. (EC) No 470/2009, Article 27 §2: for a substance that an MRL has been established under Regulation (EEC) No 2377/90, the Commission or a Member State may also submit to the EMEA a request for an opinion on extrapolation to other species or tissues

Hope for future treatment under cascade



ADDITIONALLY

✓ REG. No 2092/91 on organic production of agricultural products ...

BEEKEEPING:

The use of veterinary medicinal products in beekeeping which complies with this Regulation shall respect the following principles:

(e) without prejudice to the principle in (a) above **formic acid, lactic acid, acetic acid and oxalic acid** and the following substances: **menthol, thymol, eucalyptol or camphor** can be used in cases of infestation with *Varroa jacobsoni*.

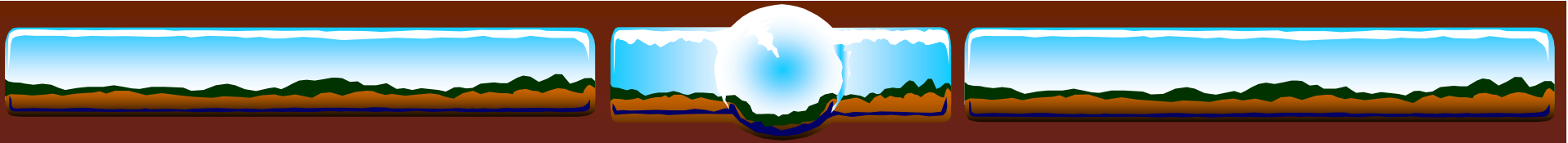
(a) they can be used in so far as the corresponding use is authorised in the Member State in accordance with the relevant Community provisions or national provisions in conformity with Community law;

✓ DIRECTIVE 2001/82/EC on the Community code relating to VMP

Article 5: No veterinary medicinal product may be placed on the market of a Member State **unless a MA has been granted** by the competent authorities of that Member State in accordance with this Directive or a MA has been granted in accordance with Regulation (EC) No 726/2004.

For the above substances to be legally used as VMPs, 'products' should be granted MA.

No MA so far.
