

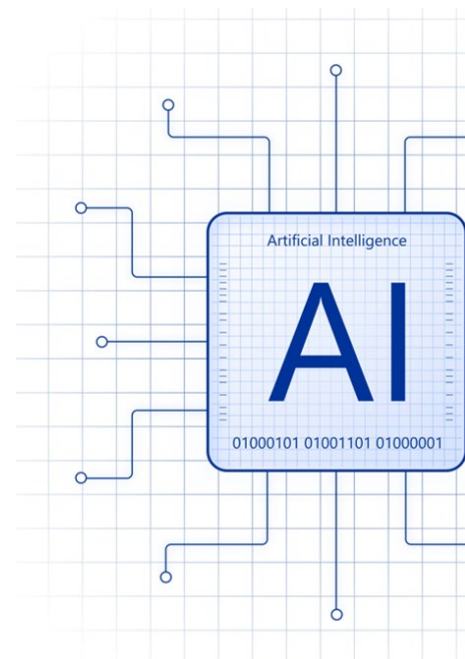

Background

- Long history of work on AI in the EMRN
- In 2020 EMA establishes two taskforces:
 - Digital Business Transformation Taskforce
 - Data Analytics and Methods Taskforce
- AI public workshops in 2021 and 2023
- Adoption of AI multi-annual workplan by EMA Management Board in December 2023.



AI Workplan to 2028

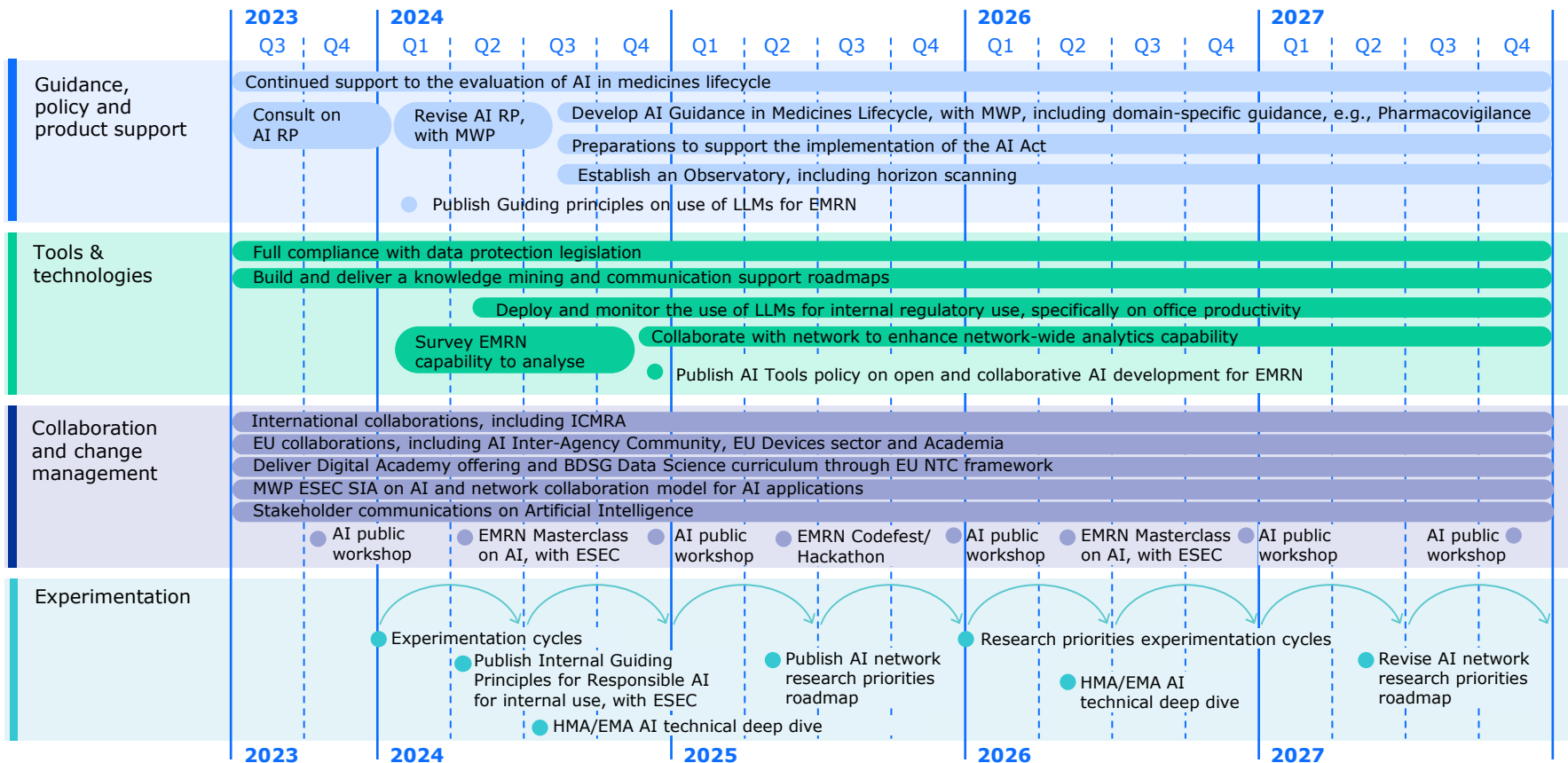
- The AI Workplan to 2028 was developed in collaboration with the Network and stakeholders
- The drafting was informed by:
 - BDSG discussions in September/October 2023 where national and EMA initiatives were presented
 - Feedback from stakeholders at AI Workshop on 20/21 November 2023
- The AI workplan was endorsed by HMA and EMA MB in December 2023
- Given the rapid evolution in this field, the AI workplan implementation and maintenance will be overseen by the BDSG, with regular update to HMA and EMA MB



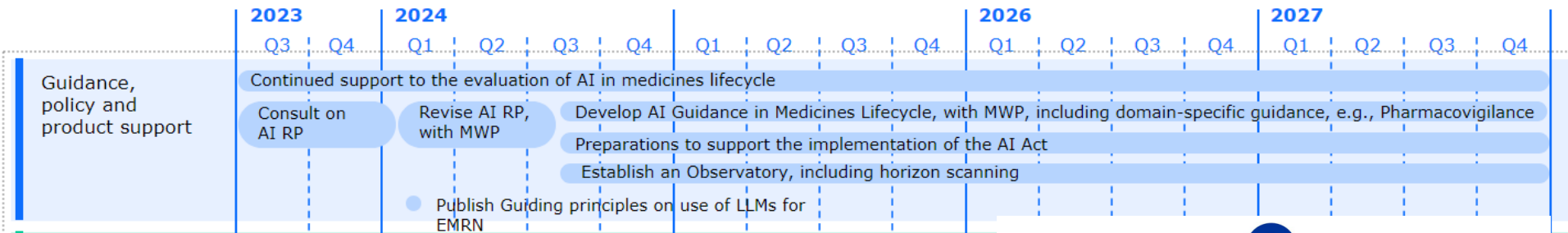
Multi-annual AI workplan 2023-2028

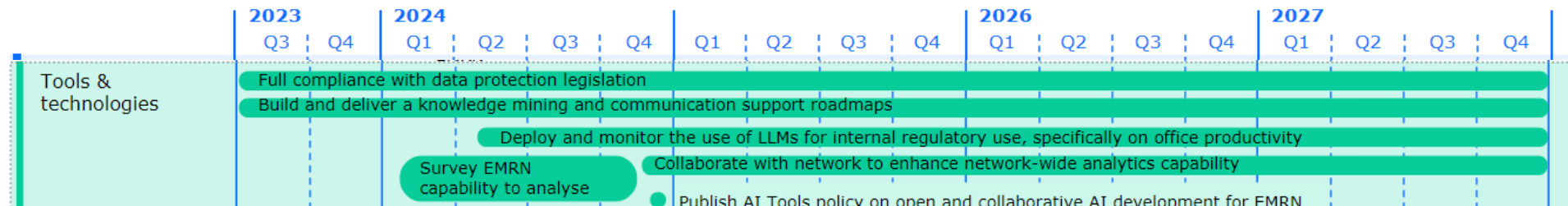

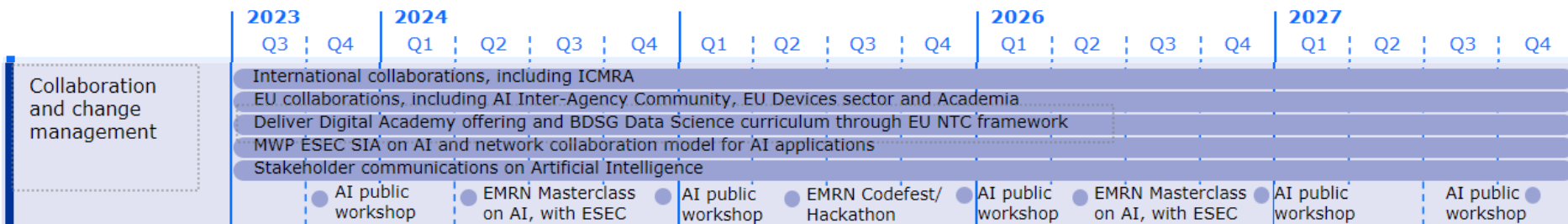
Tools and Technology

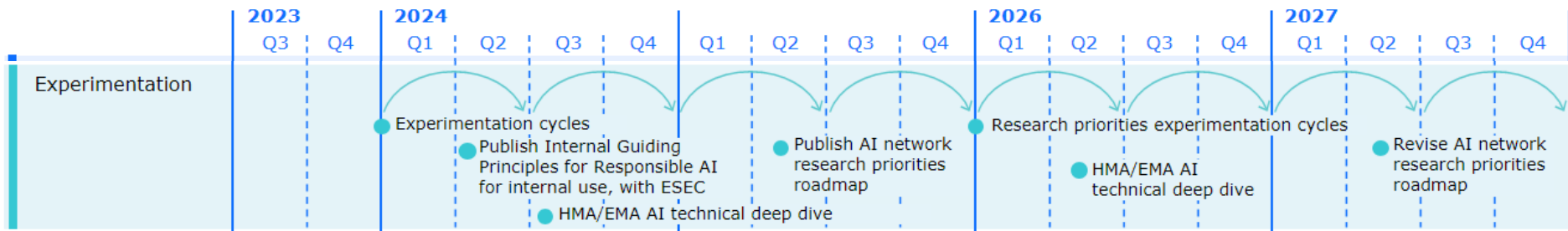
ASSISTED VALIDATION SYSTEM	PERSONAL DATA REGISTRATION	DOCUMENT COMPARISON
Assisted Validation System for Vets is a tool that leverages AI to validate variations faster and more easily. The system automates many aspects of the applications sent to EMA by using a mix of AI technologies to: - flag documents that are missing from the application; - detect anomalies and differences between information submitted by applicants and data stored in EMA databases; and - identify changes made by applicants in their submissions across all EU languages. The benefit of this tool is automating the registration and the validation of Type IA, B, and
