PRESS RELEASE Inauguration of the new Committee on Herbal Medicinal Products

The new Committee on Herbal Medicinal Products (HMPC) held its inaugural meeting on 23 and 24 September 2004 at the EMEA in London. The launch of the new Committee follows the publication of a new Directive regarding traditional herbal medicinal products (Directive 2004/24/EC*) earlier this year. This new piece of European legislation introduces a simplified registration procedure for traditional herbal medicinal products in the EU Member States and establishes a Committee on Herbal Medicinal Products as part of the European Medicines Agency.

During the inaugural meeting the new Committee members and interested parties heard speeches from Paul Weissenberg (European Commission), Giuseppe Nisticó (rapporteur for the Directive during his time as Member of the European Parliament) and Dagmar Roth-Behrendt (Vice-president of the European Parliament. They all played key roles in developing European legislation for herbal medicines.

Thomas Lönngren, EMEA Executive Director, welcomed the Committee members at the EMEA. "The new Committee is a unique assembly of the best scientific experts in the field of herbal medicinal products on EU level. It will help to harmonise procedures and provisions concerning herbal medicinal products laid down in the Member States and to further integrate herbal medicinal products in the European regulatory framework."

The Committee will provide the Member States and the European institutions with the best possible scientific opinion on questions relating to herbal medicinal products. Its tasks include in particular the establishment of a draft list of herbal substances, preparations and combinations, and the elaboration of Community herbal monographs.

At the meeting Dr. Konstantin Keller (Germany) was elected as chairman and Dr. Heribert Pittner (Austria) as vice-chairman. The Committee has one member from each of the 25 EU Member States, in addition to one member each from Iceland and Norway. Each member has one alternate.

- Dr Keller is a pharmacist and head of the division of herbal, homoeopathic and anthroposophic
 medicinal products at the Federal Institute for Drugs and Medical Devices in Bonn since 1983. He
 was the chairman of the Herbal Medicinal Products Working Party (HMPWP) at the EMEA
 between 1997 and 2004.
- Dr Pittner is a medical doctor, specialising in pharmacology and toxicology. He is currently
 deputy head drug authorisation at the Austrian Ministry of Health and Women. Dr Pittner was the
 vice-chairman of the Herbal Medicinal Products Working Party (HMPWP) between 2002 and
 2004. He is also a member of the Committee for Medicinal Products for Human Use (CHMP) at
 the EMEA.
