## HMPC meeting report on European Union herbal monographs, guidelines and other activities

The 103<sup>rd</sup> HMPC meeting, held on 24-26 January 2022

### European Union herbal monograph review

Upon recommendation from the Rapporteur, the HMPC decided, after systematic review according to the procedure<sup>1</sup> EMA/HMPC/124695/2011 Rev. 2, to start the revision procedure for the following monographs because new data were identified that could change the monograph's content:

- EU herbal monograph on Eucalypti aetheroleum
- EU herbal monograph on Rhodiolae roseae rhizoma et radix

The revision of the monographs and supporting documents will be added to the HMPC work programme.

Furthermore, the HMPC decided, after systematic review, that no revision is required for the following monographs because no new data were detected that could change the monograph's content:

- EU herbal monograph on Aloes folii succus siccatus
- EU herbal monograph on Cichorii intybi radix
- EU herbal monograph on Eucalypti folium
- EU herbal monograph on Fraxini folium
- EU herbal monograph on Fucus vesiculosus
- EU herbal monograph on Marrubii herba
- EU herbal monograph on Origani dictamni herba
- EU herbal monograph on Sennae folium
- EU herbal monograph on Sennae fructus
- EU herbal monograph on Urticae folium
