Report on budgetary and financial management

Financial year 2011

Introduction

This report summarises the budgetary and financial management by European Medicines Agency during the financial year 2011. It outlines the financial situation and the events which had a significant influence on activities during the year.

The report has been drawn up in accordance with Article 76 of the Agency's Financial Regulation, updated as of 7 October 2010 and Article 80 of the Implementing Rules to the Financial Regulation as of 7 October 2010.

For information about the Agency's business objectives and the degree of achievement, please refer to the Annual Activity Report and the Annual Report.

1. Financial Management in general

1.1. Initial budget and amending budgets

Authorised appropriations in the European Medicines Agency's initial budget for 2011 totalled EUR 208,863,000.00, representing a 5.39% increase over the initial 2010 budget (EUR 198,187,000.00), and 0.23% over the final 2010 budget (EUR 208,387,000.00).

One amending budget was introduced in 2011 to change the grade of 5 posts in the establishment plan from AST1 and AST3 to AD6. This amendment had no impact on overall numbers of posts, nor on the overall volume of staff related appropriations.

1.2. Revenue

Revenue entered in the accounts as at 31 December 2011 amounted to a total of EUR 199,346,126.96.

Of total revenue, 80.23% derived from the agency's own resources for the evaluation of medicines and other business related activities and 19.77% derived from the European Union budget to fund various public health and harmonisation activities, as described in the work programme (in 2010: 76.86%/23.14%).



As stipulated in the Financial Regulation, budget revenue is based on cash received for contributions received from the European Union, fees for marketing license applications for pharmaceutical products and for post-authorisation activities as well as for various administrative activities.

Table 1 below presents the implementation of the revenue budget of the European Medicines Agency in financial year 2011.

The figure of EUR 44,160.00 posted under 'recovery orders waived by the authorising officer' relates to debts with companies in administration/liquidation which had to be written off.

1.3. Expenditure (commitments and payments)

Commitments totalled EUR 198,862,912.76 or 95.21% of final appropriations (2010: 95.65%). Payments totalled EUR 163,003,895.34 or 81.97% of commitments entered into (2010: 79.10%). Table 2 below shows the implementation of the expenditure budget of the Agency in financial year 2011.

1.4. Carry-over from 2011 to 2012

Automatic carry-over to financial year 2012 totalled EUR 35,859,017.42 or 18.03% of the appropriation committed (2010: 20.90%). One non-automatic carry-over to financial year 2012 was requested, totalling EUR 3,200,000.00 (see Table 3), or 1.53% of the final appropriation (2010: 1.68%).

Automatic carry-over of administrative appropriations (Titles I + II) decreased from EUR 18.7 million in 2010-11 to EUR 7.2 million in 2011-12, while automatic carry-over of operational appropriations (Title III) increased from EUR 22.9 million in 2010-11 to EUR 28.6 million in 2011-12.

1.5. Carry-overs from 2010 to 2011

Automatic carry-overs to financial year 2011 totalled EUR 41,655,049.44. Payments against the carry-overs equalled EUR 39,341,486.19 or 94.45% (2010: 97.05%). Hence the amount cancelled was EUR 2,313,563.25.

One non-automatic carry-over from 2010 to 2011 was processed for a total of EUR 3,500,000.00. Payments against this non-automatic carry-over totalled EUR 2,906,262.15 or 83.04% (2010: 93.20%) and the amount cancelled was EUR 593,737.85.

1.6. Appropriation from assigned revenue

No appropriation from assigned revenue was available in 2011.

1.7. Transfers

The Executive Director may, in line with Article 23(1) of the Financial Regulation, make transfers within a title and up to 10% of appropriations from one title to another. Transfers *per se* are not an indicator for deficiencies in financial management but a necessary tool to adjust the budget in a changing environment, e.g. the use of interim staff instead of contract staff, increased expenditure due to exchange rate fluctuation, etc. Only if and when the changes also relate to changes in the work programme might they indicate shortcomings in the planning process.

During 2011 eight transfers were approved. All were adjustments only, within the limits of Financial Regulation and approved by the Executive Director. They totalled EUR 10,471,100 or 5.01% of final appropriations (by comparison, in 2010 thirteen transfers amounted to EUR 13,714,500.00 or 6.58% of final appropriations). The transfers were primarily used for expenditure on buildings and information technology and other adjustment on administrative budget items. Annex I provides details of the transfers carried out in 2011.

In 2011 the Agency had neither transfers above the 10% ceiling set by the Financial Regulation as adopted by the Management Board, nor changes to its work programme.

1.8. Cancellations

Expenditure appropriations should be understood as estimates only and not as an entitlement to create corresponding commitments. Being reliant on fee income means that the Agency can only use expenditure appropriations as and when corresponding fee income has been received on the bank

account. Therefore the level of cancelled expenditure appropriations does not indicate delays in implementation of the work programme but is a result of stringent monitoring of actual revenue and adjustments to the expenditure.

For 2011 appropriations totalling EUR 6,800,087.24 were cancelled amounting to 3.26% of final appropriations. By comparison, in 2010 appropriations amounting to EUR 5,574,296.49 were cancelled, while EUR 3,500,000.00 was the subject of a non-automatic carry-over to 2011 (i.e. resulting in reported cancellations of EUR 9,074,296.49 in the 2010 report on budgetary and financial management).

2. Financial management by chapter

Hereafter follows an analysis of revenue (based on cash collected) and expenditure (based on commitments) in 2011. It contains details of the various chapters of total revenue and expenditure and comparison against 2010 figures. The use of the most important expenditure items is also explained.

Table 4 below sets out the amounts recovered in 2011 in comparison with those for financial year 2010.

In budgetary terms, EUR 86.7 million (43.53% of total 2011 revenues) represent the proportion which can be considered stable, since it relates to annual product maintenance fees received for both human and veterinary medicines activities, EU and EEA contributions, as well as to contributions to joint programmes undertaken by the Agency. In 2011 52.09% of the total revenue depended on cyclical business activities (details in table 5).

Table 6 below sets out how committed funds in 2011 were expended in comparison with financial year 2010. It should be noted that in 2011 the four chapters and articles with the highest amounts committed, accounted for 85.55% of total commitments (2010: 96.62% of total commitments). They are:

- Chapter 11 'Staff in active employment' (33.08%)
- Chapter 20 'Investments in immovable property, renting of buildings and associated costs' (9.93%)
- Chapter 31 'Expenditure for corporate data processing' (8.16%) and
- Article 301 'Evaluation of medicinal products' (34.38%).



2.1. Income chapter 10 'Revenue from services rendered (fees for the evaluation of medicines)'

Fee income from evaluation services is the main source of revenue for the Agency, representing 75.85% of 2011 revenues (2010: 73.37%). Fee income, in terms of cashed receipts, decreased by 1.61% between 2010 and 2011. This is due to the fact that for a considerable amount of fee income (EUR 19.1 mio.) recovery orders were raised in 2011, but the revenue will only be cashed in 2012 or later. The decrease does therefore not reflect a drop in activity levels, but rather is a consequence of the principles of accrual basis accounting, whereby reported income represents cash received from pharmaceutical industry for applications for the evaluation of medicinal products. The value of recovery orders / invoices for fees rose by 9.6%, when compared to 2010, reflecting the increase in activities.

2.2. Income chapter 20 'EU contributions'

This chapter accounted for EUR 38,238,742.64, or 19.18%, of 2011 revenues (2010: 22.46%). Of the contributions received, EUR 4,719,605.00 (12.34% of total contributions) relate to compensation for fee reductions granted for orphan medical products.

With the establishment of the budget for the European Union, the Budgetary Authority had agreed total contributions for the agency of EUR 38.42 million in commitment appropriations. Of this total, EUR 181,257.36 for the compensation of orphan fee reductions remained uncollected.

The contributions from the European Union budget fell by EUR 8.81 million (-18.73%) between 2010 and 2011. This decrease was due to the full offsetting of the 2009 surplus against the 2011 EU contribution, compared to a partial offsetting of the 2008 surplus against the 2010 EU contribution.

2.3. Income chapter 30 'Participation by third countries in EMA activities'

This chapter represents the compensation received for the participation of EEA countries in the Agency's activities. It accounted for 0.39% of 2011 revenue. The actual amount receivable is calculated as a percentage of the general contribution, i.e. the EU contributions excluding EU contribution derived from Agency surplus. The percentage used for 2011 was 2.60%.

2.4. Income chapter 52 'Revenue from administrative operations'

Chapter 52 includes the income from administrate charges for export certificates, parallel distribution as well as bank interest derived from fee income (excluding bank interest received on EU contributions). The chapter accounted for 4.30% of 2011 revenues (2010: 3.32%).

2.5. Income chapter 60 'Contributions to EU programmes and revenue from services'

This chapter accounted for 0.20% of 2011 revenues (2010: 0.28%).

The revenue relates mainly to the grant received from DG Enlargement for the implementation of the IPA programme¹ where the advance payment of the grant is included in the financial accounts and accounted for in the budgetary accounts in line with actual expenditure (commitments) for the year.

Other revenue items relate to the grant received from the IMI-PROTECT and the IMI-EU2P programmes² via IMI Joint Undertaking, an Executive Office of the European Union, as well as contributions from external participants at a conference organised in the context of the IPA programme.

A new programme, known by its acronym, GRIP³, started in 2011 and will be part-funded by a grant from the corresponding 7th Framework programme (FP7).

2.6. Income chapter 90 'Miscellaneous revenue'

This chapter accounted for 0.08% of 2011 revenues (2010: 0.17%).

2.7. Expenditure chapter 11 'Staff in active employment'

Chapter 11 accounted for 33.15% of 2011 expenditure, constituting the second largest share of expenditure (2010: 31.10%).

51.84% of Chapter 11 expenditure related to item 1100 'Basic salaries' and 20.65% to 1190 'Weightings'. For these two items commitments amounted to EUR 48,458,158.14.

The 7.84% increase between 2010 and 2011 can be explained mainly by the increase in weighting. In 2010 the average weighting was at 20.3 compared to 34.4 in 2011. This weighting increase, retroactively applicable as of July 2010, should have been processed in financial year 2010. However, it was processed by the Commission's Paymasters Office in February 2011, together with a salary adjustment, resulting in a correspondingly higher impact on 2011 appropriations.

New recruitment, promotions and step advances had less of an impact on expenditure than normally, due to the fact that no additional posts were available for 2011.

Global Research in Paediatrics

Basic salary and allowances were frozen at July 2010 levels by the Council of Ministers at the end of 2011. As a result, the 2011 figures do not include the effect of any backdated change to the salaries, exchange rate or weighting. Any subsequent correction to 2011 salaries, be it positive or negative, which may be awarded by court decision would need to be charged to the financial year in which the decision will eventually fall.

A total of EUR 659,000 was transferred from the chapter.

The total number of staff at year-end increased from 656 to 689 (+5.03%). As per 31.12.2011, the Agency had a total of 552 temporary agents, 118 contract agents and 19 national experts on secondment (2010: 546, 94 and 16).

In 2011, the Agency advertised 15 vacancies for temporary agent positions.

As for gender distribution of staff, women accounted for 40% of Section Heads and Heads of Sector but none of the Heads of Units or the Executive Director as at 31 December 2011. See Table 7 and Figure 2 for details.





Figure 3 Staff by country (temporary staff and contract agents)

The distribution of staff by country is shown in Figure 3.

Figure 2 Staff by gender (temporary staff and contract agents)

2.8. Expenditure chapter 13 'Missions and duty travel'

This chapter accounted for 0.25% of 2011 expenditure with a total of 992 missions carried out (2010: 0.30% and 1,177 missions).

Compared to 2010 there was a reduced level of participation in international activities and fewer missions of long duration.

A total of EUR 230,000.00 was transferred from the chapter.

2.9. Expenditure chapter 16 'Social welfare'

Chapter 16 accounted for 0.10% of 2011 expenditure (2010: 0.06%).

The increase in expenditure reflects higher than forecast contribution to 'early childhood centres and other crèches'.

A total of EUR 93,000 was transferred to the chapter.

2.10. Expenditure chapter 17 'Entertainment and representation expenses'

The fall in expenditure between 2010 and 2011 reflects a return to a level below the long-term average, after the additional expenditure related to the 15th anniversary of the Agency in 2010.

EUR 3,000 was transferred from the chapter.

2.11. Expenditure chapter 20 'Investment in immovable property, renting of buildings and associated cost'

Chapter 20 accounted for 9.93% of 2011 expenditure, compared to 9.40% in 2010.

The increase in expenditure was related to 'Project 2014', new head quarters for the Agency.

The chapter was reinforced by a total of EUR 4,743,000.00.

2.12. Expenditure chapter 21 'Expenditure on data processing'

Chapter 21 accounted for 4.29% of 2011 expenditure (2010: 15.45%).

The lower expenditure level can be explained by the creation of a new article under Title III for expenditure related to operational IT programmes, cf. chapter 31. Overall, ICT expenditure (chapters 21 and 31) decreased by 18.32% compared to 2010.

The chapter was reinforced by EUR 1,163,000.00 through various transfers as adjustment between administrative and operational ICT expenditure in chapter 31.

2.13. Expenditure chapter 24 'Postal charges and telecommunications'

This chapter accounted for 0.25% of 2011 expenditure (2010: 0.31%). The fall in expenditure of almost 20%, when compared to 2010 is due to lower postal rates and less usage of surface mail overall.

A total of EUR 445,000.00 was transferred from the chapter.

2.14. Expenditure article 301 'Evaluation of medicinal products'

Article 301 accounted for 34.38% of 2011 expenditure (2010: 34.79%). The slight fall reflects the composition of fee types, with annual fees making up a higher fraction of fee income compared to 2010. The share of annual fees paid to (co-)rapporteurs is 30%, compared to 50% for other fees.

A total of EUR 3,022,000.00 was transferred from the article.

2.15. Expenditure article 303 'Studies and consultants'

This article accounted for 0.04% of 2011 expenditure Compared to 2010, expenditure in 2011 increased by 31.01%.

The company PriceWaterhouseCoopers was contracted to conduct a programme of IT audits in 2011. This increase was partly offset by the move of expenditure related to staff management consultancy to item 1171 'Professional services related to staff management'.

No transfers were made to or from the article.

2.16. Expenditure article 304 'Information and publication'

This article accounted for 0.05% of 2011 expenditure. Expenditure decreased by 24.33% between 2010 and 2011, or EUR 31,831.35.

The lower expenditure can be explained by the cancellation of participation in a convention, resulting in savings.

No transfers were made to or from the article.

2.17. Expenditure Chapter 31 'Expenditure on corporate data processing'

This chapter was created in 2011. Expenditure was previously allocated to chapter 21. Overall, ICT expenditure (chapters 21 and 31) decreased by 18.32% compared to 2010, cf. point 2.12 above.

A total of EUR 1,163,000.00 was transferred from the chapter as adjustment between operational and administrative ICT expenditure in chapter 21.


