## Revision of budget structure from financial year 2017

With the implementation of the new Financial Regulation and its provision on multi-annual programming, the European Commission's has provided guidelines for the programming document including various templates, such as a template for the financial statements. The Agency's current budget structure does not fully reflect the Commission's template for the expenditure statement and therefore it is suggested to align our budget structure on chapter level to achieve compliance with the Commission's template. The proposed changes shall come into effect as of financial year 2017.

Annex I gives an overview of the current and revised structure including the template of the European Commission for the financial programming.
