Scientific recommendation on classification of advanced therapy medicinal products

Article 17 – Regulation (EC) No 1394/2007

Brief description (or name when available) of the active substance(s)

Viable human autologous skin fibroblasts.

Brief description of the finished product

Autologous skin fibroblast suspension.

Proposed indication

Filling of skin connective tissue loss (skin wounds).

EMA/CAT conclusion

The procedure was finalised on 20 May 2016 for the following recommendation.

On the basis that the product:



- consists of engineered cells or tissues, which have been subject to substantial manipulation, so that biological characteristics, physiological functions or structural properties relevant for the intended regeneration and repair are achieved;
- is administered to human beings with a view to regenerating and repairing a human tissue,

the EMA/CAT considers that the product falls within the definition of a tissue engineered product, as provided in Article 2(1) of Regulation (EC) 1394/2007.
