I am a member of ESCMID, Slovenian Antimicrobial Therapy Society (part of Slovenian Medical Association), Slovenian Society for Clinical Microbiology and Hospital Infections (part of Slovenian Medical Association) and Slovenian Immunology Society.

I believe that my colleagues at the University Medical Center Ljubljana may provide consultancy advice to pharmaceutical companies (I do not know for which companies or which products) - because University Medical Center Ljubljana is considered the highest research and referral medical center in Slovenia. It is possible that some departments in the UMC Ljubljana have interests medical device companies or notified bodies.

However, I do not have direct or indirect interests in medical device companies or notified bodies, and neither do my close family members as far as I am aware.

I am also member of a group of experts appointed by the Ministry of Health to assess adverse effects after vaccinations against covid-19 (to assess if adverse effects are vaccine related or not).
