Her over 10 years of experience at the Bulgarian Drug Agency (BDA) help her to duties in her professional career.

As the first president of the Bulgarian HTA Competent Authority (National Council on Prices and Reimbursement of Medicinal Products 2013-2014) she started an EU-project-OPAC for establishing of electronic database of medicinal product. At that time she involved the Bulgarian HTA competent authority (National Council on Prices and Reimbursement) in the EUnetHTA network.

Her regulatory experience was accumulated as CRO- Betaconsult Pharma Ltd. (2007-2013) and BORA-Clinical Research Organisation, where was involved in drug regulatory and clinical trials management in different therapeutic fields.
