EGAN did not receive any grants from pharmaceutical industry in 2018 or 2019. Their total budget in 2018 was around Euro 15000, in 2019 this will be around the same amount.

Roche contributed in natura by covering travel costs for some EGAN participants in a workshop on patient involvement in drug innovation in Basel in both years. The workshop is open for other patient organisations as well. I did not attend these workshops.

I am employed by the Dutch Federation of Cancer patient organisations (www.nfk.nl).

In 2018 NFK received a grant from Janssen-Cilag of ? 10.000 for a project called 'Better informed choice for patients in the palliative setting'. for the same project in 2019 we received a grant of ? 20.000. I did not gain any profit of that nor was I involved in the execution of that project. The total budget for NFK in 2018 was 2.4 million euros, in 2019 this will be around 3.3 million euro's (so the industry part was less than 1% of our annual budget).

The major sponsors of NFK are the Dutch Cancer Foundation (KWF, charity fund) and PGO foundation (money from the Dutch government).
