Annex III – List of EU Medicines Regulatory Agency Organisation with single and multiple LOC IDs for PMS data enrichment

The table below lists the appropriate LOC IDs to be used for EU-based organisations with multiple identifiers when entering data in PMS field 2.8. Please note that if an EU Medicines Regulatory Agency organisation updates its address (ie. LOC ID merges, unmerges) and therefore LOC ID, the information in this table may no longer be valid. Additionally, not all organisations may be listed.

Note: This exercise was limited to National Competent Authorities (NCAs) involved in human medicines, as these could be feasibly contacted by the Agency.

Organisations not covered, such as other EU and non-EU organisations responsible for issuing manufacturing authorisations, were excluded due to resource constraints. As a result, **if a specific authority is not listed in Annex III to Chapter 2**, users are advised to contact the relevant organisation directly to confirm the appropriate LOC ID to be used.
