² Review of new information to decide on a necessary update of monographs/ list entries is initiated by time elapsed since the previous published version (Periodic review after at least 5 years) or by data submitted to HMPC (Unscheduled review) in accordance with Procedure for the review and revision of EU herbal monographs and list entries (EMA/HMPC/124695/2011 Rev. 2). The review step before revision was introduced in 2018. The outcome of the review is: (I) yes, revision is needed because of new data of relevance for the content of the monograph or (II) no revision needed. For (I) the revision procedure is started ending with a new opinion on a revised monograph/ list entry and supporting documents. Previous documents are marked as superseded but remain on the EMA website. For (II) a summary of new data is published as an Addendum to the existing assessment report. Monograph and all supporting documents remain unchanged.
