Scientific recommendation on classification of advanced therapy medicinal products

Article 17 - Regulation (EC) No 1394/2007

Brief description (or name when available) of the active substance(s)

Recombinant adeno-associated virus type rh10 containing a transgene that encodes a microRNA targeting SOD1 messenger RNA under the control of an H1 promoter.

Brief description of the finished product

Suspension of product vector particles for injection.

Proposed indication

Treatment of amyotrophic lateral sclerosis due to mutations in SOD1.
