# Scientific recommendation on classification of advanced therapy medicinal products

## Brief description (or name when available) of the active substance(s)

Expanded autologous auricular chondrocytes.

### Brief description of the finished product

Auricle and wedge-shaped grafts consisting of expanded autologous auricular chondrocytes within a 3D-printed polymer matrix.

### **Proposed indication**

Surgical implantation for the repair of microtia.
